Once the deposit is paid you are committed to paying for the whole of the Phase. This is nonrefundable and non-transferable and irrespective of whether you finish the Phase

Modules are from Thursday 14:00 to Sunday at 12:30/13:00 or 16:00 (to allow for travel). Modules 1, 5, 8, 9 and 10 start at 9.00am on the Thursday. Otherwise modules run from 9:00 to between 18:00 & 19:00. Instructors reserve the right to begin and end classes slightly earlier or later (except Thursday start and Sunday end) and will publish their exact times and schedules.

Inter-Phase Paper: you will be required to hand in a paper approximately one month after Phase 2 ends. This will be a relatively short paper based, on notes you have been keeping during the Phase about your process of embodying Rolfing theory and how it was to give and receive sessions in class. The purpose of the paper is to help you transition to new teachers and real clients in Phase 3 and is not a pass/fail paper.

Total cost of Phase 2 is £7200.00. Payments will be: non-refundable deposit and then each module as indicated in the table above.

<sup>\*</sup> There is a deposit for Phase 2 (£2200) payable in advance. £220 will then be deducted from the fee for each Module and £500 will be the payment per Module. Once you are accepted to Phase 2 and deposit is paid you are committed to paying for the whole of the Phase. This is non-refundable and non-transferable and irrespective of whether you finish the Phase or not.



Post-Phase 2 Mentoring Sessions: you will be required to undergo two mentoring sessions with approved mentors between Phases 2 and 3. Mentoring sessions can be taken one to one with the mentor or in groups of up to four students. These sessions will run from a minimum of two hours and will be partly subsidized by the school. A group of students will pay less than one student (£98). The subjects for mentoring will arise from your needs as you undergo study. The mentoring sessions are there to support your transition from one phase of study to another and to open up different points of view and styles of working.

Post Phase 3 Mentoring sessions: you will be required to participate in three mentoring sessions (as above) with approved Mentors within a year after completing Phase 3 -- before your Supervision workshop (see below).

Total cost for Phase 3 is £5400.00. Payments will be: non-refundable deposit and then each module as indicated in the table above.

## **Supervision**

In order to maintain your Certified Rolfer<sup>™</sup> status, you are required to complete a Supervision weeklong workshop roughly one year after you qualify. Currently these are taken at the European Rolfing<sup>®</sup> Association e.V. training centre in Munich. ### Payment terms

Fees are payable per module at least 4 weeks in advance of the module by internet bank transfer to British Academy of Rolfing:

A deposit is required at the beginning of each phase, a proportion of which is then deducted from the fee for each module. The deposits are due once you have received an offer of a place on each respective phase.

Once the deposit is paid you are committed to paying for the whole of the Phase. This is non-refundable and non-transferable and irrespective of whether you finish the Phase or not. The Phase 1 Application Fee covers the cost of application to the course, and is not refundable even if the application is unsuccessful.

**Financial Aid and Loans:** We offer a staggered payment plan for each phase, as outlined above, to allow students to spread the cost of the training.

**VAT Please note:** students ARE required to pay any VAT on course fees. As an educational organisation, the British Academy of Rolfing is EXEMPT from VAT under current British law. Should the law change students will be required to pay VAT.
